

# Conceptual and practical issues in monitoring animals

## Continuing Education March 10, 2005

Paul F. Doherty, Jr. and Gary C. White Dept. of Fishery and Wildlife Biology, Colorado State University, Fort Collins, CO

Monitoring activities continue to increase with many monitoring plans being developed. We will give a current review and appraisal of these activities. We will focus on philosophical approaches to monitoring, as well as design issues – with an emphasis on discussing novel developments in probability-based sampling methodology and methodologies to account for detection error. We will detail these developments with a goal of conceptual understanding. We will close with a discussion of educational opportunities to further explore these developments

In 1998, I graduated from Utah State University with a B.S. in Fisheries and Wildlife Management and I completed a M.S. in Zoology and Physiology from the University of Wyoming in 2003. During my college years, I was employed by the UDWR, USFS, and USU Co-op Unit. I worked on projects related to Bonneville and Colorado River Cutthroat conservation, whirling disease, June Sucker culture, Boreal Toads, and a host of projects aimed at improving sport-fishing conditions.

Since my escape form the academic world, I have been employed as a regional fisheries biologist for the Wyoming Game and Fish Department in Cody.

I have been involved with AFS since 1996, participating in the USU Student Chapter, Bonneville Chapter, UW student sub-unit and our chapter. I was the V. President and President of the UW Student sub-unit, assistant-editor for "The Angler", and currently co-chair the program committee.

I believe the AFS and our chapter have much to offer the membership and the resources we steward. The AFS enables us to look beyond the borders of our region and states and develop a better understanding of how our work fits within a much larger ecological framework. We might not identify ourselves as "fish rescuers" but we all work towards common goals. #### **Matt Kondratieff**



I grew up in a rural area of northern California a quarter mile from a 3,700-acre nature preserve operated by the California Academy of Sciences. My interest in fish and wildlife was sparked by time I spent on the preserve, exploring grassy, oak-covered hills, poking around vernal pools, and roaming through redwood-choked canyons. My specific interest in fisheries began after assisting a graduate student with his fish monitoring project in Suisun Marsh, CA. I received a B.S. in 1996 from U.C. Davis in wildlife, fisheries, and conservation biology with an emphasis in fisheries biology. After graduation, I worked on a fish treadmill project designed to investigate the effectiveness of various fish diversion screens on threatened and endangered fish species found in the CA Bay-Delta region. I then moved to Colorado to begin work on a MS project investigating the question of how high brook trout can jump through direct experimentation. I graduated with my M.S. in 2003 from CSU under the guidance of Dr. Chris Myrick. Since that time, I worked as a fisheries technician for the Colorado Division of Wildlife and I am currently a fisheries biologist for the Wyoming Game & Fish Department in Pinedale, WY. My primary responsibilities are centered on native cutthroat trout restoration, managing sport fisheries in impoundments and lakes and managing headwater streams.

I have been a member of AFS since 1995. My first introduction to AFS was while attending UC Davis as an undergraduate. I was invited to serve as community outreach chairperson for the student chapter in 1995. My interest in fisheries biology was fueled through my involvement in the AFS student group, including attending my first Cal-Neva Chapter meeting. In 1996, I served as vice-president of the student chapter. My involvement with AFS continued when I became a graduate student at CSU, where I served as the student chapter president in 2001. As an undergraduate, I had the opportunity to assist with a study on leopard shark movement rates. I presented

results from this study at the 34<sup>th</sup> Annual Cal-Neva AFS meeting in Ventura, CA. I presented my graduate research to the CSU student AFS chapter in fall of 2002, the International Congress on the Biology of Fishes in Vancouver, British Columbia, Canada in 2002, the CO-WY AFS chapter meeting in Grand Junction, CO in 2003, and the recent Western Division AFS meeting held in Salt Lake City, UT in 2004. I was honored to be the first recipient of the CO-WY AFS student scholarship in 2002. Also in 2002, I was co-winner, along with Julian Olden, of the CSU AFS student chapter award for outstanding service.

Since joining the Wyoming Game & Fish Department, my involvement with the CO-WY Chapter has continued. This past year, I served as committee chairperson for the procedures manual update. Updating the procedures manual helped me to become familiar with various roles and functions of the membership serving within the CO-WY AFS chapter.

# A Guide for Presenters at the Chapter Meeting

If you're planning to present a paper at the Annual Meeting, here are some guidelines to make things go smoothly:

#### **Check List for Presenting a Paper**

- Submit abstract (<350 words) prior to February 23<sup>rd</sup>.
- Create a presentation that will fill the 20 minutes allotted, allowing 3-5 minutes for introduction and questions.
- Bring your presentations to the 2005 chapter meeting on CD (CDR) in Microsoft PowerPoint compatible format. A slide projector may be available, but no other media will be allowed.
- Download your talk to the meeting lap-top at registration. Please try to load your presentation the night before or during a break well in advance of your scheduled time to speak. DO NOT wait until you're scheduled session to load your presentation. Presenters with access to the Wyoming Game and Fish network are requested to electronically deliver talks prior to the meeting by contacting Craig Amadio. However, it's advised that you bring a backup copy to the meeting, just in case.
- Contact the session moderator as soon as possible when you arrive at the meeting.
- Present your paper. Relax, giving a presentation isn't as hard as you think. Just remember, nobody knows as much about your presentation as you!

#### **Check List for Presenting a Poster**

- Submit abstract (<350 words) prior to February 23<sup>rd</sup>.
- Create an easily readable poster.
- Bring your poster to the meeting. Locations for posters and directions for hanging will be provided at registration.
- Stand near your poster during dedicated poster breaks to answer questions.

# Chapter ExCom Meeting Highlights Fort Collins, Colorado December 2, 2004

Editor's note: Due to limited space, the ExCom meeting minutes are only highlighted here. The full minutes can be found on the Chapter website.

Attendees: Dave Zafft (Past President), Mark Smith (2005 Annual Meeting-Program Co-Chair), Hilda Sexauer (Vice-President), Anita Martinez (President), Rosemary Black (2005 Annual Meeting-Arrangements Co-Chair), James Dominguez (CO Membership Committee Co-Chair), Greg Anderson (WY Membership Committee Co-Chair), Boyd Wright (CSU Student Subunit President), Mario Sullivan (CSU Student Subunit), Kendall Ross (CSU Student Subunit), Mike Bower (UW Student Subunit President), Scott Gangl (Angler Newsletter Editor), Brett Johnson (Continuing Education Committee Chair), and Lori Martin (Secretary-Treasurer)

Anita Martinez called the meeting to order, and the Sept. 2004 ExCom Meeting minutes were approved.

Greg Anderson provided information to the ExCom regarding the professional display board that he would like the Chapter to purchase for \$2,000.

Dave Zafft provided background information regarding "Bylaws," "Rules," and "Procedures" in relation to funding procedures. In terms of Endowments Funding, the Procedures are formal and were adopted in 2002. Such Procedures are temporarily in place until February 2007, or until the CSU Endowment Fund is fully endowed at \$20,000. Discussion followed regarding what should be included within the new Endowment Funding Bylaw, such as where the funding for the endowments would come from, and what portion of the endowment would be funded annually. The new Endowment Funding Bylaw would be voted on at the annual business meeting.

Dave Zafft discussed the Grant Funding Procedures, and indicated that currently, there is discretionary funding within the Bylaws to fund up to \$2,000 for grant applications. The \$2,000 funds are considered seed money, with the expectation that should these funds be granted, repayment is expected. Further discussion revolved around the Chapter's process once grant requests are received, and review and editing of the current Bylaw.

Anita Martinez indicated that the Continuing Education Committee does not currently have funding available to bring in speakers. Continuing Education should target professionals, and be worthy of topics that would provide interest and learning opportunities for the Chapter membership. The Continuing Education Committee is hindered from providing such opportunities without a funding mechanism. Dave Zafft indicated that within the Bylaws, money is available to assist with Continuing Education.

Boyd Wright (CSU Student Subunit President) and Mike Bower (UW Student Subunit President) presented subunit updates. Both subunits will receive \$100 from the Chapter to assist with annual meeting travel expenses. Additionally, the CSU subunit will receive \$250 from the Chapter to match subunit funds raised for the Louis Swift Scholarship.

The 2005 Annual Meeting was discussed in detail. Members of the Arrangements, Registration, Program, and Continuing Education Committees were present. A special session on aquaculture will occur the morning of March 9<sup>th</sup>, following the business meeting. The half-day Continuing Education Workshop, "Principles of Sample Design and Population Monitoring" will be taught by Drs. Gary White and Paul Doherty of CSU. Each professor will receive an honorarium of \$250 from the Chapter for their efforts. Discussion also focused on annual meeting support, best student paper/poster judging, awards, the raffle, the business meeting agenda, and fundraising.

Discussion occurred regarding reviewing and revising the Procedures Manual. Revision comments should be received by the beginning of 2005. A majority vote of the ExCom will be required for approval.

Discussion followed regarding a potential illicit fish introduction policy that the Environmental Policy Committee is pursuing. Chapter rules on advocacy, policy statement development, and options for change were discussed.

Hilda Sexauer reported that she will continue with the transition to tie the Chapter's website into the Western Division's website.

Standing committee reports were given for the Newsletter and Membership Committees, as well as the Chapter Archivist. James Dominguez was introduced as Colorado's new representative on the Membership Committee.

#### Temporary Fishery Positions Available with the Colorado Division of Wildlife

Four temporary positions involving fisheries work will be available beginning in April and May 2005 with the Colorado Division of Wildlife. The six month positions will be based out of Grand Junction and Steamboat Springs. The positions will include: nonnative fish control operations, surveying fish populations in rivers, streams, reservoirs, and ponds in NW Colorado by using electrofishing, gill nets, trammel nets, and seines; inventorying cutthroat trout populations; collecting, preserving, labeling, and shipping fish for disease testing, genetic analyses, and stable isotope studies; and data entry. Employees will be expected to: work long hours in adverse conditions, backpack in the mountains, work out of and operate rafts and aluminum boats in rivers and reservoirs. and wade in streams and rivers while electrofishing or seining. Employees will frequently be out of town during the work week, as extensive overnight travel for extended periods of time will be required. Necessary requirements include: a driver's license, the ability to swim, heavy lifting (outboard motors, portable generators, dipnets full of fish, etc.); the ability to winch a boat on a trailer; a good attitude; interest in the biological sciences; and the ability to work and get along with others. Fish identification; experience towing trailers and with boat handling; a mechanical aptitude for working with small engines; the ability to use computer programs such as Access, Excel, and Word; training in a field of biology related to natural resource management; and prior experience will be considered when selecting employees. Salary for the positions will range from \$10.52/hour to \$11.30/hour, depending on qualifications. # Google Scholar Provides Free Search for Online Academic Documents

The Internet search organization Google has released a new free tool called "Google Scholar" that allows you to look up any author, or publication or technical topic and find all of the other articles or websites that cite that work, ordering them by relevance. "Google Scholar" enables you to search specifically for scholarly literature, including peer-reviewed papers, theses, books, preprints, abstracts and technical reports from all broad areas of research. "Google Scholar" also automatically analyzes and extracts citations and presents them as separate results, even if the documents they refer to are not online. This means that search results may include citations of older works and seminal articles that appear only in books or other offline publications. This book contains the peer-reviewed technical papers presented at a June 2003 symposium examining the effective use of fish culture as a tool for fisheries resource management.
