Happy New Year! I hope your first three weeks of the New Year have been enjoyable. Remember, the 2006 annual meeting is rapidly approaching and we guarantee an excellent educational program and an enjoyable social event. The theme for the 2006 annual meeting is "Adventures in Fisheries - Evolution of Techniques and Technologies". The continuing education workshops and the plenary session will highlight the theme and should appeal to a wide array of biologists.

Two continuing education workshops will be offered this year. On Monday afternoon a ½ day workshop will cover the perspectives, goals and programs of the U.S. Fish And Wildlife Service's Aquatic Animal Drug Approval Partnership. The course will include information on the FDA's Investigational New Animal Drug exemption and New Animal Drug Application processes. The instructors will discuss chemicals, therapeutics, vaccines and anesthetics used in aquaculture, fish management and research. One of the new chemicals discussed will be the Anesthetic Agui-S®. This workshop is **FREE**! The second workshop is offered on Thursday March 9th. The course will provide detailed instruction on how to use All Topo Maps software and will be helpful for those who use topographic maps for locating routes to a field site, as well

as to those who are interested in more

advanced techniques, such as creating custom maps that can interface with GIS software. The course will be valuable to the novice or experienced user for professional and nonprofessional events.

On Tuesday morning the meeting will kick off with a plenary session on "The evolution of piscicide application". The panel of piscicide experts will discuss the application of piscicides, historical to present, and the politics and challenges agencies are confronted with during planning and implementation. Contributed papers will follow the plenary session. There will be two social events plus the banquet dinner this year. The welcoming social will begin at 7 pm on Monday and a social arranged by the CSU and UW Student Subunits will be held on Tuesday. This is an informal event and will provide an excellent occasion for professionals to interact with their future aquatic biologists.

I want to invite all biologists to this annual meeting and ask them to take advantage of this excellent opportunity to share their knowledge of the resource with their colleagues and to build professional friendships. *Hilda's Vent continued on Page 5*

NO presentation or poster will be turned down.

Final deadline for presentation and poster abstract is February 13, 2006.

Abstracts for contributed papers and posters should be prepared as MS Word or WordPerfect file in 12 point, Times New Roman font, left aligned and include the following information.

- 1. A brief descriptive title.
- 2. Names, addresses, telephone and FAX numbers, and email addresses for all organizers. Presenter must be clearly identified
- 3. An abstract of 350 words or less.
- Indicate whether presenting a poster or oral presentation. Please indicate the presentation type 2x2 slides or using an LCD projector and PowerPoint Presentation.
- 5. Indicate if presenter is a student.
- 6. Indicate length and width of poster.

Two Continuing Education Courses to be Held at Annual Meeting

Aquatic Animal Drug Approval Partnership March 6th, 2006 1:00 p.m. – 6:00 p.m.

Aquatic Animal Drug Approval Partnership staff
U.S. Fish and Wildlife Service
Bozeman, Montana

This ½ day workshop will cover the perspective, goals, and programs of the U.S. Fish and Wildlife Service's Aquatic Animal Drug Approval Partnership (AADAP), pertinent to fisheries management and aquaculture. The FDA's Investigational New Animal Drug (INAD) exemption and New Animal Drug Application (NADA) processes will be discussed from the end-users' perspective. Instructors will focus on all aspects of drug, chemical, therapeutant, and vaccine use in fisheries management and aquaculture.

Many new chemicals show great promise for fisheries management applications, such as the "zero-withdrawal" anesthetic Aqui-S®, but must first receive Federal Drug Administration (FDA) approval. Instructors from AADAP will describe how fisheries workers apply to participate in trials of new drugs. Particular attention will be paid to the current and future participation of workshop attendees in the U.S. Fish & Wildlife Service's INAD program and how to maximize its benefits to participants, the overall drug approval process, and the goals of fisheries management and aquaculture.

A Guide for Presenters at the Chapter Meeting

If you're planning to present a paper at the CO-WY Chapter Meeting, please follow these guidelines:

Presenting a Paper:

- Submit abstract (≤350 words) prior to February 13th.
- Time allotted for each presentation will be 20 minutes: 1 minute for introductions, 15-16 minutes for the presentation, and 3-4 minutes for questions.
- The only acceptable formats for presentations are 2"x 2" slides or computer LCD projection using Microsoft PowerPoint. If additional formats are necessary (i.e., Corel Presentation) please contact Beth Bear for arrangements.
- Save presentation as your last name followed by first name as the presentation title.
- Submit presentation in Microsoft PowerPoint format on C.D., by Monday, February 27th to:

- *Please send an email confirming that a presentation has been sent or emailed to: Beth.Bear@wgf.state.wy.us so that receipt of presentation can be verified.
- If not submitted by February 27th, presentations should be brought to the meeting on CD (CDR) or USB Flash Drives in Microsoft PowerPoint compatible format.
- At the meeting, presentations will be downloaded to the meeting computers at registration. Presentations must be downloaded by 8:00 pm on the evening before your talk.
- If using 2" x 2" slides, please bring your slides in a labeled carousel to your scheduled room at least 1 hour before your session is scheduled to start so that AV workers can prepare it for projection and you can receive last-minute instructions regarding AV equipment. Use only an 80-slide carousel. Slides may jam in the larger 140-slide carousels.
- Please bring a backup copy of your presentation to the meeting, just in case.
- A preview room will also be available so speakers can make sure slides are arranged correctly.

Presenting a Poster:

- Submit abstract (<350 words) prior to February 13th.
- Create an easily readable poster.
- Bring your poster to the meeting. Locations for posters and directions for hanging will be provided at registration.
- Stand near your poster during dedicated poster breaks to answer questions.

Nominate a Coworker for a Chapter Award

The Colorado/Wyoming Chapter has three award classifications for recognizing our fisheries professionals and the Awards Committee needs your help in determining qualified candidates. This is an opportunity for you to become involved and see that your professional peers receive the deserved recognition from this Society. Please take a moment and think about your professional peers that have made significant contributions and accomplishments to our aquatic resources. It is your responsibility to make sure our professionals receive this recognition.

The following are the awards and criteria.

AWARDS OF EXCELLENCE

- Significant efforts in the advancement of the fisheries' profession, beyond routine expectations.
- A milestone work contributing to the understanding/conservation/management of aquatic resources.
- Original advancement or innovations in fishery research, culture, or management techniques.
- Significant contributions, via public education and participation to conservation of aquatic resources.
- Imaginative and successful programs in aquatic resource conservation education.
- Leadership in recognition/development of habitat issues that lead to a legislation/policy that protect/enhance the aquatic resource.
- Development of aquatic research, culture or management programs of regional or national significance.
- Important ecological discoveries or new taxonomic criteria.
- New philosophies or ideas that contribute to the understanding or management of aquatic resources.
- This is a lifetime award; therefore an individual may only win this award once.

"MAX" AWARD of MERIT

- "Atta Boy or Girl" award for a job well done, an outstanding effort in aquatic resource conservation, a major contribution to the well being of the fisheries' professions, creation of a new "whiz bang" idea or any act that elicits that warm all over feeling. This award generally recognizes significant short-term accomplishments.
- All persons associated with water resources, regardless of affiliation are eligible for this ward.

LEAKY BOOT AWARD

 This is an award for recognition of extreme decadence even beyond the norms for a fish squeezer. It recognizes the most outrageous behavior in the year subsequent to the Chapter's

- annual meeting. The benefits is to show that all persons have value, even if it's only for use as an example of initiative gone awry.
- This award can be given to any fisheries student or professional, even if they might not want it.

Our goal is to make Chapter awards significant and truly reflect our recognition of our peers and others that help the fishery and aquatic resource. We need your nominations to make this work. CSU AFS Spring Fishing Derby

We are currently planning our Annual Fishing Derby to be held in April. A tradition for more than 25 years, our derby is held at College Lake and has become our biggest fundraiser. Our tickets sell for \$30, of which \$10 from each ticket goes to the Louis Swift Scholarship, awarded to a deserving fisheries student. Because we limit ticket sales to 100, we often have long lines of people who show-up hours before opening on the day of sale.

Our derby allows access to a restricted lake that offers large pike, crappie, yellow perch, carp, and "unofficial state record size" bass. Prizes donated by local fishing shops and breweries are awarded for the largest bass, largest pike, most fish caught, most inches caught, largest pike on a fly rod (sponsored by New Belgium Brewery), and smallest fish caught.

The derby is not only a long-standing tradition here at CSU; the Lefort family has had three generations participate in our event. And, in memory of Evan Lefort, a generous donation from the family was used to establish the Evan Lefort Memorial Award for the Largest Pike Caught. The winner of the award has his name engraved on a plaque displayed in the Wagar Building at CSU.


Chronicles of the Fish People at the University of Wyoming

Kathy Foster

I grew up in the suburbs on the Front Range in Colorado. Fortunately for me, my family had a historic mountain cabin on the North Fork South Platte River, which became my escape from city life and my introduction in the great outdoors. The cabin is over



100 years old and was a stop on the Narrow Gauge Railroad between Denver and Leadville. It has been in our family for over 50 years. Going to the cabin every weekend was a great way to learn about the natural environment. Experiencing the daily fluctuations of the river in front of our cabins is what first piqued my interest in water. The North Fork South Platte River serves as a conduit for water delivery from Dillon Reservoir on the west side of the Continental Divide to Denver on the east side of the Divide.

I received a B.S. in Watershed Sciences from Colorado State University in 1986. My first professional job was as a hydrologic technician with the Forest Service on the Routt National Forest in Steamboat Springs, Colorado. I continued working as a hydrologic technician in Wyoming and Montana and as a hydrologist in Idaho with the Forest Service. I soon realized that I needed to diversify my profession since my husband at the time was also a hydrologist with the Forest Service and two hydrologists in the same family make it very hard for a dual career couple. Also, with a more diversified background, we could weather the looming federal budget cuts at the time better. Fisheries was the logical choice, given my background in hydrology since the physical and biological are intricately entwined. I got my fisheries from the University of Idaho, Moscow in 1993. I have been working as a fisheries biologist since starting on the Idaho Panhandle National Forest and am currently the South Zone Fisheries Biologist on the Medicine Bow – Routt National Forests in Steamboat Springs,

Colorado. I guess I've come full circle. I feel I've combined the best of both worlds with hydrology and fisheries. My primary responsibilities include Colorado River cutthroat trout management and restoration, boreal toad population and habitat monitoring and assessing impacts and recommending mitigations for land management activities.

I have been involved with AFS since 1993, participating with the University of Idaho Student Chapter, Idaho Chapter and currently the Colorado-Wyoming Chapter. Since 2003, I have been the Awards Chair for our chapter.

As a candidate for this position, some of my desires are to increase participation from our current membership, increase our membership and continue to support our excellent chapter. I am honored to be nominated as a candidate for our Chapter's Secretary-Treasurer Office. I appreciate your consideration for this position.

Meeting called to order at 8:40 a.m. A quorum of officer was present.

Approval of September 2005 Business Meeting Minutes
Hilda Sexauer made a motion to approve the September 22,
2005 minutes. Anita Martinez seconded the motion and the


