### The Vent Ann Widmer

The last time our chapter held a joint meeting with the Colorado Chapter of the Wildlife Society was 17 years ago, in 1994. Ken Kehmeier was president. I dug through a thick three-ring binder of our chapter's annual reports hoping to find an amusing anecdote from 1994 for you, but (sadly) didn't find more than basic meeting statistics. What I did find were distinct patterns in our chapter's activities. Our chapter was working through many of the same issues 17 years ago that we are dealing with today, such as the role of our chapter in advocacy, the dispersal of chapter funds, membership engagement, alternative locations for annual meetings, issues-oriented meeting topics, and chapter continuity. We return to these key topics every few years as if they were new.

How do we improve chapter continuity so that our chapter can achieve something truly new and forward the mission of our society, rather than cycling through a handful of used topics? In the January 2010 edition of the Angler, past-president Mark Smith pointed out that almost all committee members are less than 40 years old and have fewer than 10 years of professional experience. Therein lies our problem—our committee members, although talented and hard working, were probably not chapter members 17 years ago. We lose a lot of institutional knowledge with the rapid turnover in our committees. Furthermore, not many of us have ready access to the old chapter reports or the time to sift through these materials.

In working with the Colorado Chapter of the Wildlife Society on the upcoming meeting, I learned that a number of their committee positions are manned by retirees. It is brilliant! These more experienced

members are extremely savvy when it comes to meeting planning and have saved us a lot of time and money. So, where are our CO-WY AFS retirees? Wayne Hubert is temporarily off the hook since he ambitiously became President of AFS after retiring last year, but how about the rest of you?

I have the honor of presiding over the upcoming 2011 chapter business meeting. If at that meeting you find yourself muttering under your breath, "Didn't we decide on this 17 years ago?" please do the following:

- 1. Take a moment to acknowledge your chapter president was 16-years-old (and not a chapter member) in 1994;
- 2. Share some good stories about the last joint meeting at the banquet; and
- 3. Seriously consider volunteering for a chapter committee position. We will make room for you, I promise.

### CO/WY AFS Annual Meeting February 22-25, 2011 Fort Collins, CO





In 2011 the local chapters of the American Fisheries Society and The Wildlife Society will be holding a joint meeting in Fort Collins, CO from February 22 to 25. The theme for this years' meeting is **"From the Cradle to the Grave: Recruiting and Retaining Natural Resource Recreationists"**. This theme was chosen due to its timeliness and because it spans the missions of all agencies, as well as sporting and environmental organizations.

The meeting will begin with a day and a half of invited speakers followed by a day of contributed papers from our members. Some of this year's invited speakers include the Secretary of the Interior (or an undersecretary), Directors of the CDOW and WGFD, Chief of USFWS Division of Wildlife and Sport Fish Restoration, CEO of the Humane Society, Forest Preschools, Department Chair for CSU Fish, Wildlife,

and Conservation Biology Department, National Director of Project Wild and Project Learning Tree, and Ted Nugent. The final day will highlight contributed papers and will have two concurrent sessions (Fisheries session and a Wildlife session). A draft of the full program is available on the chapter website.

- 3. An abstract of 350 words or less.
- 4. Indicate whether presenting a poster or oral presentation. Only PowerPoint presentations are accepted.
- 5. Indicate if presenter is a student.
- 6. Indicate length and width of poster.
- 7. Indicate whether presentation is "informational" or follows "scientific method" (helps in judging process).

The Colorado/Wyoming Chapter has four award classifications for recognizing our fisheries professionals and the Awards Committee needs your help in determining qualified candidates. This is an opportunity for you to become involved and see that your professional peers receive the deserved recognition from this society. Please take a moment and think about your professional peers that have made significant contributions and accomplishments to our aquatic resources. It is your responsibility to make sure our professionals receive this recognition.

**Award of Excellence:** Recognizes (since 1980) an individual who has made significant contributions in the fishery-aquatic resource field. This award was formerly (1977-79) known as Fishery Worker of the Year Award.

Max Award of Merit: In honor of Max Rollefson (WGFD), this atta boy recognizes a short-term professional accomplishment in management, administration, research or culture. This award evolved from the original Stream Habitat Award (1977-1982) and (since 1991) has been broadened to recognize accomplishments in a wider range of aquatic endeavors.

**Outstanding Mentor Award:** This award will recognize a fisheries professional who has shown substantial devotion to assisting or mentoring prospective fisheries students/professionals, current fisheries students, or fisheries professionals.

**Leaky Boot Award:** Recognizes the most outrageous behavior of any fisheries student or professional in the year subsequent to the chapter's annual meeting.

Please limit applications to one page for the "Max", Mentor, and Leaky Boot Awards. Award of Excellence nominations are typically more detailed with letters of support from multiple individuals.


## To contribute to the 2011 annual meeting raffle!


## Course 1: Adaptive Fish and Wildlife Management

Adaptive management is about making the best possible decision, in the face of various sources of uncertainty, and at the same time trying to reduce that uncertainty. To achieve that, the decision process is decomposed into its elements (management objectives, set of alternative actions, predictions of the consequences of those actions, and monitoring to evaluate the decision and the predictions). Each element is considered, debated, and constructed, and then the elements are re-assembled and a decision is derived from the connections between these pieces. This approach brings rigor, clarity, and transparency to consideration of what can often be a complex and confusing process. This clarity applies not just to decisions related to managing the resource, but monitoring decisions as well. During the workshop we will discuss the process above and the elements of an informed decision. For each element we will discuss what is needed to make the decision process

rigorous and transparent (e.g., attributes of clearly expressed objectives, and examples of how conflicting objectives can be balanced to develop an objective function; how the process can be used to get the most out of monitoring dollars). The format for the workshop will be a combination of lecture, discussion of case studies, and small group discussion.

### Course 2: Environmental Conflict & Collaboration

This six-hour training session will combine lecture and facilitated activities to introduce participants to the basics of environmental conflict, human communication and behavior in complex problem solving. It will introduce innovative process design ideas for engaging in productive conflict management and collaboration with stakeholders. The session will begin with an overview of the key principles of conflict resolution and applications to natural resource issues (10am - 12pm). After an hour lunch break, we will resume with an in-depth discussion of how to better understand the human factor in conflict situations, including interpersonal communication and relational dynamics and how they influence the potential for collaboration. Finally, we will explore techniques for facilitating workshops, meetings and collaborative efforts spanning from the nuts and bolts of organizing to integrating innovation into the standard public meeting.



After graduation, I made the move back to Wyoming and started working for the Wyoming Game and Fish Department. From 2005 to 2009 I worked on various

native fish projects in eastern Wyoming and the Bighorn basin. Since 2009, I have been working on aquatic invasive species for the state and have been the coordinator of the aquatic invasive species program since April 2010.

I am not sure I know what "spare time" is anymore but if I have some I enjoy getting outside with my husband Steve, our 3 year old son Tyler, and our two pups. We're expecting another boy in the next few weeks that should complete the wonderful chaos that is our life.

I have been involved in various aspects of AFS since about 2002 as a member of the Parent Society, member of the Montana Chapter, member of the Montana State University Chapter, and best of all as a member of the CO/WY Chapter since 2006. Paul Gerrity
Candidate for Secretary-Treasurer



Growing up in Cleveland, OH on the shores of Lake Erie, my interest in fisheries began at a very young age. During summers and autumns a weekend rarely passed when I was not fishing Lake Erie for yellow perch, walleye, or smallmouth bass with my dad and two uncles. During the winters and early springs I fished northern Ohio rivers for steelhead every chance I got. It's not an understatement to say that through grade school and high school fishing was pretty much my life. Although I enjoyed the outdoors and fishing so much, I didn't realize that I wanted a career in fisheries until my junior year as Biology major at John Carroll University in northeastern Ohio. That is when a graduate student introduced me to Ohio Division of Wildlife (ODW) fisheries biologists that he worked with. I immediately thought that those biologists had the greatest jobs in the world because they got to work on Lake Erie almost every day and had the opportunity to make management decisions to protect and improve the fishery that I grew up with. After meeting those fisheries biologists I spent three field seasons working with them at the ODW – one summer as a creel clerk and two summers as a technician on a 52-foot trawling/gill netting research boat.

After earning my B.S. from John Carroll and finishing my last contract with the ODW in 2001, I continued my career by working as a fisheries technician at two U.S. Geological Survey field stations – one in Sandusky, OH where I continued to work with the Lake Erie fishery, and another in Dixon, CA where I assisted with research on mercury contamination in fish in central California reservoirs. After almost two years of working with USGS, I decided to move on to graduate school. In 2005 I earned my M.S. in Fisheries Management from Montana State University by studying the diet and habitat use of shovelnose sturgeon and the federally

endangered pallid sturgeon in the Missouri River above Fort Peck Reservoir in Montana. After graduating from MSU I began my employment with the Wyoming Game and Fish Department (WGFD) in Casper. I spent almost four years working for the WGFD in Casper, where my main duty was sport fish management on the reservoir and tail-water fisheries within the North Platte River drainage. Currently, I am a fisheries biologist with WGFD in Lander, where I have resided for a little over a year. My main duties in Lander are sport fish management and native species conservation in the Wind River drainage.

I have been a member of the American Fisheries Society since 1999 when I began working as a fisheries technician in Ohio. My first active involvement with the AFS occurred when I served on the Membership Committee of the Ohio Chapter of the AFS from 2001 to 2002. I was also active with the AFS during my time in Montana by assisting with the creation of the Montana State University AFS Student Subunit, serving as the subunit's treasurer from 2004 to 2005, and presenting my research at the 2004 and 2005 Montana Chapter AFS annual meetings. Since moving to Wyoming I have been involved in the CO/WY AFS Chapter in many aspects, including presenting my research at the 2010 chapter meeting, and serving as co-editor of the chapter newsletter (2006 – present), chair of the Best Paper/Poster Committee (2006 – 2007), and chair of the AV Committee (2010). I am also a Program Committee member for the CO/WY Chapter and Western Division AFS meeting that will be held in Jackson in 2012. Outside of chapter-level involvement, I have also presented research at the 2005 AFS Annual Meeting in Anchorage and the 2010 Western Division Annual Meeting in Salt Lake City. Some of my other accomplishments include publishing three peer-reviewed articles in AFS journals and becoming an AFS Certified Fisheries Professional in 2010.

Since becoming a member of the CO/WY AFS Chapter I have been very impressed with the professionalism and dedication of fellow members. If elected I would like to help keep the chapter in the direction it is already going. I'm a huge proponent of making management decisions and advocating causes based on sound science and the best available information. I believe the best ways to do this are through continuing education, information sharing at meetings, and mentoring students and young professionals.

## Travis Neebling Candidate for Secretary-Treasurer



I have been fascinated with fish since a young age. I grew up in San Diego, CA and Western Australia where I enjoyed snorkeling and SCUBA diving as well as breeding and raising many species of both native Australian freshwater fish and African cichlids. Therefore, it is not surprising that I have chosen a career that is centered on fisheries.

I have been an active member of the American Fisheries Society since 2004 when fellow undergrads and I formed a student subunit at Northland College. Following undergrad, I received my M.Sc. from Iowa State University (ISU) where I served as president of the student subunit. I strived to increase overall membership, involvement and participation within the subunit. As president I provided opportunities for scientific and professional development along with social activities for the members. My hard work (and that of my fellow officers and members) was rewarded when the ISU Student Subunit was selected as the Most Active Student Subunit in the North Central Division (NCD) for the year that I served as president.




