# The Vent

Our chapter was encouraged to submit a bid this summer to host the 2015 annual meeting of the AFS parent society in Denver. While our chapter executive committee ultimately decided not to submit a bid, I learned a number of things about our chapter during the decision-making process.

To make the decision whether to host the meeting, our chapter: 1) contacted previous meeting hosts to estimate the level of effort required; 2) surveyed the membership via an electronic survey to characterize moral support and estimate potential volunteer hours; and 3) individually contacted local agency decision makers to estimate institutional support (financial and personnel hours) for the meeting. Labor estimates from the Pittsburgh meeting in 2010 were the most detailed and relevant to our chapter. Their meeting required 22 planning committees, with about 85 people on the planning team. Most were agency staff, although they also had good support from university and private firms. They suggested that we would need the flexibility to have staff work on this for significant amounts of time, perhaps quarter time or more as the meeting approaches.

Despite these rather onerous labor projections, 75% of the 55 survey respondents said that they were excited by the prospect of the Colorado-Wyoming Chapter of AFS hosting the 2015 parent society meeting (scoring agreement  $\geq$ 4 out of 5; refer to the full survey results below). Furthermore, people were willing to put their volunteer hours where their mouths are—more than 60% of respondents (N = 34) indicated that they would be willing to serve on one of the planning committees (scoring agreement  $\geq$ 4 out of 5). Even though the survey was only open

for a short 3-day window in the heart of field season, we were able solicit to almost 50% more volunteers for the 2015 parent society meeting than we were for our 2011 chapter standing committees and meeting planning committees combined (N=24). Thus, I learned that many of our chapter members are excited by opportunities on an international scale and are willing to contribute their time to make that happen.

About half of the people volunteering time for the 2015 meeting were employees of federal agencies, universities, and consulting firms or retired. This surprised me because the vast majority of our active chapter committee members have been Wyoming or Colorado state employees in recent years. I learned that our chapter has a lot of untapped volunteer potential and substantial opportunities to diversify our committee volunteers.

While no one expressed interest in being the primary meeting organizer for 2015, 25% of respondents (N = 14, scoring agreement ≥4 out of 5) indicated that they would be willing to chair one of the planning committees. Accordingly, I learned that we have more leaders in our chapter than I had suspected, and again, that leadership is available from non-traditional sources.

The local agencies were generally excited about the professional development opportunities that hosting an international meeting could provide for their employees, but many expressed concern about the large commitments of personnel hours recommended by the Pittsburgh meeting organizers. Despite these reservations, several agencies pledged financial and personnel support to help bring this prestigious meeting to Denver. Through these discussions, I learned that all the agencies contacted were willing to support some (and sometimes substantial amounts of) employee time on AFS meeting planning. This seems somewhat at odds with the responses I received from the membership, where only 38% of the survey respondents indicated that their employer would remunerate them for  $\geq 50\%$  of the hours they spend on this activity. If you are interested in getting actively involved in AFS, I would highly encourage you to discuss this possibility with your supervisor—they may be more receptive to your involvement than you may think.

Although the executive committee was encouraged and impressed by the number people and agencies that expressed excitement and pledged support for the

meeting, we ultimately decided that we did not have quite enough manpower or primary leadership secured to move forward with the bid process for the 2015 meeting. Although we acknowledged that some of our members would be disappointed in the outcome, we felt this decision was in the best interest of the chapter.




#### Summary of 55 responses







### **Business Meeting Minutes**

Annual Business Meeting 2/24/2011, Fort Collins, Colorado

**Attendees:** Ann Widmer (President), Diana Sweet (Vice-President), Ryan Fitzpatrick (Secretary/Treasurer), Mark Smith (Past President), chapter committee members and chapter members.

**Ann Widmer (President)** – The meeting was called to order at 12:18 pm. A quorum was established with 39 members present. Dirk Miller was appointed parliamentarian. The business meeting agenda was unanimously approved.

Wayne Hubert (President, American Fisheries Society) – Wayne provided the current status of the parent society. The American Fisheries Society currently has 9,000 members in 63 different countries with membership numbers stable. Financially the organization is doing well, even though some investments took a hit with the recent decline in the economy. Wayne discussed a new process for AFS publications, online membership lists, and more attention being paid to lead in sport fishing tackle. He reiterated that people should be more active in the parent society as 25-75% of members in some chapters are not members of the parent society.

#### State of the Chapter, Ann Widmer (President) –

The current state of the chapter is strong with members occupying high-level leadership roles, including Lori Martin as the Western Division President and Wayne Hubert as the American Fisheries Society President. Within our chapter membership numbers have been remaining fairly constant. Financially we are doing well with a stable budget and the investment fund is recovering. Chapter accomplishments include developing an illicit introduction resolution, writing environmental policy statements, and conducting surveys that review our management of grants, endowments and fundraising. The current joint meeting with The Wildlife Society is increasing networking opportunities for our members. As an indication of the strength of our chapter the parent society is interested in having Colorado/Wyoming host the 2015 parent society meeting in Denver.

Secretary/Treasurer Report, Ryan Fitzpatrick (Secretary/Treasurer) – Ryan presented the current treasurer's report. Since this was a joint meeting expenses and income are mixed between AFS and The Wildlife Society. Thus, the report did not contain all information regarding the meeting. Profits for the meeting will be split evenly between AFS and The Wildlife Society. The profit goal for the meeting will be \$7,000 per society.

#### FY 12 Proposed Budget, Diana Sweet (Vice

**President**) – Diana presented a proposed budget for the 2012 Western Division meeting. The budget was based on 400 expected registrants and has an expected profit of approximately \$7,000 for the chapter. Profits will increase rapidly as the number of registrations increases above 400.

#### Committee Highlights, Ann Widmer (President) –

- Arrangements and Program Committees The Arrangements and Program committees worked closely with the Colorado Chapter of The Wildlife Society to host a joint meeting in 2011 with an anticipated attendance of over 300 people. The program focused on the recruitment and retention of natural resource recreationists. They developed an ambitious plenary session that included sixteen high-profile speakers, many of who had to be scheduled almost a year in advance of the meeting.
- Continuing Education Committee The Continuing Education Committee worked with

the Colorado Wildlife Society to provide two workshops for the 2011 annual meeting. One course covered was titled fish and wildlife adaptive management, and the second course covered facilitation and conflict resolution. Both courses were excellent and were taught at full capacity.

- Fundraising Committee This year, the Fundraising Committee worked hard to solicit donations from many non-traditional sources. Between the Colorado Chapter of The Wildlife Society and Colorado/Wyoming Chapter of AFS, the Fundraising Committee raised over \$14,000 to help offset meeting and speaker costs. The Fundraising Committee would like to thank all of the sponsors listed in the program for their generous financial support. In addition, several sponsors donated hunting or fishing-related items to our auctions this year.
- Student Liaison Committee The student liaison, Michelle McGree, coordinated with the student subunits from UW and CSU to plan and execute the 2011 annual meeting student social. She kept in touch with the student subunits during the school year and was the main contact between the chapter and student subunits, answering any questions and conveying information between the two groups. One notable achievement was establishing email addresses for the subunits themselves. The email addresses will stay the same from year to year regardless of changes in officers and will make it easier to contact students in the future.
- Awards Committee The Awards Committee
  received one nomination for the Award of
  Excellence and three nominations for the Max
  Award of Merit. All individuals nominated were
  deemed deserving of the awards by the Awards
  Committee. No nominations were received for
  the Leaky Boot Award or the Outstanding
  Mentor Award.
- has continued to sort and prepare materials for scanning to be included in the chapter's archive collection. This year, the committee delivered proceedings to the University of Wyoming and Colorado State University. The committee received a \$2,000 budget from the chapter membership for scanning our collection. This

- budget falls short of an updated quote for scanning, which was \$2,700. Therefore, the committee applied for a \$1,000 grant from the Wyoming State Historical Records Advisory Board to augment chapter monies and complete scanning.
- Endowment Funding Committee The current balance of the CSU endowment is about \$25,500 and the UW endowment is about \$30,000; scholarships in 2011 are projected to be approximately \$1,100 at CSU and about \$2,000 at UW. We currently have \$11,400 invested in the Western Division Grants Endowment fund. The committee recently completed a survey of the membership to get their input on future fundraising and spending, the results of which will be discussed later. Finally, the committee has secured a generous donation of 45% of the proceeds from the auction of one of the Wyoming Game and Fish Commissioner Big Game Licenses.
- Newsletter Committee Three issues of The Angler were produced since the 2010 annual meeting (July 2010, November 2010 and January 2011). Thanks to all who sent in submissions for the newsletters.
- Environmental Policy Committee The Environmental Policy Committee redefined the chapter's Rule 1, which guides the development and approval of chapter positions at the 2010 business meeting. No chapter positions have been developed since that time. The committee encouraged members to contact their representatives in support of the National Fish Habitat Action Plan.
- Website Committee Mark Coleman completed the development of the WordPress webpage in the fall of 2010. All the money allocated to this project during the 2010 business meeting has been paid in full. The website committee has begun crossing over information into the new website and hopes to have it online soon. The committee managed the online registration through 123-SignUp for both AFS and the Colorado Chapter of The Wildlife Society, working closely with both society treasurers.
- **Nominating Committee** This committee identified three qualified candidates from

Wyoming to run for the position of Secretary-Treasurer.

#### **Student Subunit Reports**

- Colorado State University (Zack Underwood, President) – The CSU subunit has been conducting a research project on mercury concentrations in fish in College Lake. The results of this project have been submitted to the Canadian Journal of Aquatic Sciences. Seven students attended a student colloquium in Idaho and two attended a colloquium in South Dakota. The results of the mercury project were presented at both colloquiums.
- University of Wyoming There are currently twelve active students in the UW subunit. They are working on a burbot tagging project with the CSU subunit and a brown trout tagging project.

#### **No Unfinished Business**

Announcement of new Secretary/Treasurer – Ryan Fitzpatrick announced that Paul Gerrity will be the Secretary/Treasurer for FY12.

#### **New Business**

- Proposed bylaw revision Diana Sweet presented a bylaw revision that would include language allowing for the removal of an ineffective officer by vote of the executive committee. This is becoming more common among AFS chapters nationwide as there is no current avenue to remove an incompetent officer if it is necessary. The second revision is a change in the duties of the officers, reflecting the changes in the parent society's reporting requirements. Jason Burckhardt made a motion to pass the revision. Wayne Hubert seconded the motion. Motion passed.
- Fundraising Vision Travis Neebling presented results of a survey regarding fundraising.
- AFS parent society venue in 2015 (Ann Widmer)

   Hosting the parent society meeting is a big opportunity, but will also be a lot of work for the chapter. Approximately half of the membership indicated they were interested in hosting the meeting. Moving forward, we will gauge the level of support from agencies to help staff the meeting. It was agreed that without significant agency support that our chapter would not have

- the number of individuals to sufficiently staff a meeting this large.
- UW and CSU scholarship recipients (Diana Sweet) - Sarah Laske was the recipient of the UW scholarship and Zack Underwood was the recipient from CSU for the 2009-2010 academic year.

- CO-WY AFS Chapter Award of Excellence Jason Burckhardt presented the award to Bruce Rosenlund.

Robin Knox made a motion to adjourn. Melissa Dickard seconded the motion.

#### Continuing Education - Bobby Compton and **Harry Crockett**

The 2011 joint meeting with the Colorado Chapter of The Wildlife Society featured two excellent courses that were well attended. The first course, titled "Environmental Conflict and Collaboration" was taught by CSU professor Jessica Thompson and introduced participants to the basics of environmental conflict, human communication, and behavior in complex problem solving. A second course, titled "Adaptive Fish and Wildlife Management, was taught by CSU professor Bill Kendall and introduced participants to the basics of adaptive management

decision making through lecture, case studies, and group discussions. Between the two courses, approximately 60 people participated in the workshops.

Harry Crockett stepped down and was replaced by Jesse Lepak as the Colorado representative of the Continuing Education Committee. The Continuing Education Committee is in the process of selecting courses for next year's annual meeting.
