Hello Members! The final deadline for presentations and poster abstracts is quickly approaching! So it's time to summarize the great work you have been doing over the past year and send in your abstract. As always, all topics are of interest and we will once again have a "Sharing Your Experiences" session to discuss lessons learned.

Abstracts for contributed papers and posters should be prepared as an MS Word or WordPerfect file in 12 point, Times New Roman font, left aligned, and include the following information.

- 1. A brief descriptive title.
- 2. Names, addresses, telephone and FAX numbers, and e-mail addresses for all organizers. Presenter must be clearly identified.
- 3. An abstract of 350 words or less.
- 4. Indicate whether presenting a poster or oral presentation.
- 5. Indicate if presenter is a student.
- 6. Indicate length and width of poster.
- 7. Indicate whether presentation is "informational" or follows "scientific method" (helps in judging process).

Final Call for Nominations: CO-WY Chapter AFS Awards



Thinking about that outstanding coworker, supervisor, citizen, landowner, colleague, mentor, or other character? Know someone who has made a significant contribution (this past year) to fishery or habitat management, science, or policy...or someone who was involved in an infamous fish folly?

The Colorado/Wyoming Chapter has four award classifications for recognizing our fisheries professionals and the Awards Committee needs your help in determining qualified candidates. This is an opportunity for you to become involved and see that your professional peers receive the deserved recognition from this society. Please take a moment and think about your professional peers that have made significant contributions and accomplishments to our aquatic resources. It is your responsibility to make sure our professionals receive this recognition.

Award of Excellence: Recognizes (since 1980) an individual who has made significant contributions in the fishery-aquatic resource field. This award was formerly (1977-79) known as Fishery Worker of the Year Award. The Award of Excellence was awarded to Mike Stone last year.

Max Award of Merit: In honor of Max Rollefson (WGFD), this atta boy recognizes a short-term professional accomplishment in management, administration, research, or culture. This award evolved from the original Stream Habitat Award (1977-1982) and (since 1991) has been broadened to recognize accomplishments in a wider range of aquatic endeavors. The Max Award of Merit was awarded to Patrick Lionberger last year.

Outstanding Mentor Award: This award will recognize a fisheries professional who has shown substantial devotion to assisting or mentoring prospective fisheries students/professionals, current fisheries students, or fisheries professionals. The Outstanding Mentor Award was awarded in 2010 and has not been awarded since.

Leaky Boot Award: Recognizes the most outrageous behavior of any fisheries student or professional in the year subsequent to the chapter's annual meeting. Ben Swigle earned the Leaky Boot last year.

Please limit applications to one page for the "Max", Mentor, and Leaky Boot Awards. Award of Excellence nominations are typically more detailed with letters of support from multiple individuals.



Continuing Education Workshop

"Instream Flow Principles and Water Law Concepts for Fishery Managers"



This six-hour training session will provide an introduction to water law and instream flow principles pertaining to Colorado and Wyoming. The workshop will review the history of instream flows, current laws, applications, and water rights concepts from both states. The instructors will also describe instream flow methodologies and strategies to manage water from a biotic perspective (fish, invertebrates, and habitat). A portion of the course will examine past examples of planning, implementation, and monitoring, as well as the role of the public in the water rights arena. The session will provide an opportunity for participants to discuss potential projects at the end of the workshop.

I believe the American Fisheries Society plays an important role in the development of fisheries professionals and advancement of aquatic sciences. AFS promotes science-based fisheries conservation, provides networking opportunities, and assists in the development of fisheries professionals at all levels. AFS has played an important role in my professional development and I look forward to the opportunity to serve the Colorado/Wyoming Chapter.

I grew up at the confluence of two great rivers, the Mississippi and Missouri in a small town called Portage des Sioux, MO. The Mississippi River was literally a stone's throw from my childhood home. As a youngster my free time was spent exploring the river, it's backwaters and sloughs and their contents. I recall one of my favorite gifts as a child was a fine-meshed "butterfly net"; with it and a minnow bucket I'd embark on an adventure and return home to fill various aquaria with my findings. Of course, I'd often substitute a fishing rod for the net..... Though I didn't realize it at the time, my relationship with the river and its organisms shaped me like a river shapes its alluvium. Summers through high school and into college, when I wasn't working on my grandpa's farm, I worked at a marina on the Mississippi River. It was as if the muddy waters were flowing through my veins.

I attended Truman State University a liberal arts and sciences university in the northeast corner of Missouri intending on a Biology major, but a career choice still uncertain. It wasn't until my first fisheries job as an undergraduate working as a Stream Research Assistant for the Missouri Department of Conservation that I realized a job working in fisheries was what I always wanted. In this position I evaluated the effects of riparian forests on the rate of lateral stream channel migration in northeast Missouri. Truman State University did not have an AFS student subunit, so it was a supervisor with MDC that introduced me to the American Fisheries Society. I presented at the 1997

MO AFS meeting and remember thinking what a great way for fisheries professionals to share and refine ideas. From that point on I was "hooked" on AFS. My research also earned me the MO AFS best undergraduate project award.

After completing my bachelors in Biology, an opportunity to work with the Wyoming Game and Fish Department presented itself. I looked forward to the challenge of working out west with salmonids in streams and rivers that were much different from those with which I was familiar. I moved to Laramie in the spring of 1998 with the intention of working my eightmonth contract, and have called Wyoming home ever since. I was fortunate enough to work temporary jobs with the WGFD for three statewide fisheries crews, Fish Population, Reservoir Research, and Instream Flow, before beginning graduate school at the University of Wyoming in 2000. My graduate project was aimed at correlating whirling disease infection to habitat attributes across the Salt River watershed of western Wyoming and eastern Idaho. While in grad school I began dating my wife, Laura, a fellow fish squeezer. I finished grad school and began working as a regional fisheries biologist in Cody in 2002. A large component of my current position is the conservation, restoration and management of native Yellowstone cutthroat trout. Laura and I have two little ones, Madison (2 years) and Joshua (11 months) and we enjoy spending time together and introducing our little ones to our great outof-doors!

I've been involved with AFS participating in various chapter, division, and national meetings. My involvement with AFS has included a variety of roles. I was Treasurer of the University of Wyoming AFS subunit, and on the Program Committee for the 2004 Western Division AFS meeting. I have served on the Awards Committee for the Colorado-Wyoming Chapter since 2009, serving as chair of this committee since 2010. I have always valued my opportunity to serve this chapter and would like to further this involvement.

I would like to continue the good work this Chapter has been doing, fostering the development of fisheries students through the subunits, and the development of fisheries professionals at all levels through the dissemination of fisheries information at annual meetings and continuing education opportunities. I would like to lead our Chapter into taking more advocacy roles and increasing involvement with the multitude of fisheries professionals within our states that are not involved with AFS. Our Chapter faces many challenges with shrinking agency and personal budgets and I would like the opportunity to address these challenges. Thank you for your consideration and I hope to serve you in the coming years.

My wife's extended family in Illinois frequently asks me the question, "Are you still out West counting fish and going to those fish meetings?" The answer is always a resounding yes. The only variation to my answer is where I am currently counting fish or going to meetings, and the type of fish I am counting (although I'm not sure if they are really interested in the different types). I began my counting obsession with a fishing rod at the local lakes and streams growing up in Trinidad, Colorado. From a young age, I always loved being outside and fishing gave me a perfect outlet for this trait.

I began college at CSU in 1993 as a wildlife major, but changed to fisheries thanks to my great friends and mentors at the CSU Larval Fish Laboratory. For my first field season as a 19-year old, they shipped me out to Dinosaur National Monument to collect fish larvae (and swim, hike, and fish in my spare time). I was sold on this career and the rest is history. I continued to work for the Larval Fish Lab through my undergraduate degree and quite a few years after graduation. I counted minnows, suckers, and chubs in the South Platte, Republican, Arkansas, Purgatoire (my home river!), Rio Grande, Colorado, White, Green, and Yampa Rivers. Needing more cold-water diversity, I worked for the Idaho Game and Fish Department for three field seasons and counted salmon, steelhead, and bull trout in the Clearwater, Snake, Selway, and Salmon Rivers. Ready to further my fisheries career, I completed my graduate degree at the University of Wyoming counting the "three species" in southwest Wyoming and worked under more great mentors.

That work at UW lead to my hiring with the Wyoming Game and Fish Department, for whom I currently work as a fisheries biologist. I began my employment with WGFD as a state-wide aquatic habitat biologist, then moved to Green River and worked as a regional fisheries biologist, and now work on the Aquatic

Assessment Crew as a state-wide native fish biologist. My wife Koreen (and fellow fish counter) and I live in Laramie with our newborn son Marshall.

Pursuing a fisheries career can be challenging and can take you on a wild ride. When I was early in my career, I was happy just counting fish as long as it allowed me to bounce around the Rockies. Then I started to understand what it takes to be a successful biologist. Being a member of the American Fisheries Society has given me an opportunity to interact with the folks I look up to, listen to and present on current topics at Chapter, Division, and National meetings, and work to be a professional. I lurked, but didn't fully participate in the CSU sub-unit during my undergrad, but have steadily increased my desire to participate in this fine organization. I started by reluctantly volunteering to head up AV for one chapter meeting, and then willingly served as president for the UW sub-unit in grad school. Since then I have co-chaired the Continuing Education and the newly created Mentoring Committees. I have enjoyed organizing education courses for our members the past six years and am helping to establish a mentoring program that will train future professionals. After participating in the AFS Leadership course last spring in Jackson, I knew I wanted to increase my role within the chapter.

It would be a privilege to serve as the voice of our chapter. If elected, I would continue to encourage participation, provide training for current and future professionals, run a quality annual meeting, and promote our occupation. Committee Updates

CSU Student Subunit, Submitted by Eric Gardunio: The CSU Sub-unit has had good attendance at biweekly meetings last semester thanks to a strong cohort of freshmen and sophomore Fisheries Students at CSU. The meetings were diverse, with topics including fish culture, stable isotope analysis, northern pike predation on rainbow trout versus white suckers, improvement of white sturgeon spawning substrates, native fish passage, and cutthroat trout genetics.

In addition to the meetings, we are attempting to get a few activities together for next semester to foster additional student involvement. We are planning to hold both a spring and fall fishing derby at College Lake in 2013. We have garnered support from Colorado Parks and Wildlife (CPW) and CSU for our disinfection procedure to ensure that there is no transportation of New Zealand mudsnails from the lake to other waters by anglers. The two derbies will help us make up financially for not having had a derby in 2012, and allow a study of catch rates between the spring and fall derby to explore the option of permanently moving the derby to the fall semester. Additionally, plans are being discussed with CPW to initiate a field study to facilitate student involvement. We are discussing a project in the North Fork of the Cache la Poudre watershed focused on sampling to examine the possible persistence of native fishes in a tributary stream that may be isolated from invasions by non-native piscivores like brown trout. Additionally, we are planning to work with CPW to put on a Kids Fishing Day with the Larimer County Boys and Girls Club. This has been

a fun opportunity for both our members and the kids involved, so we are excited to get it going again.

We have struggled financially this year due to the lost funding from the College Lake fishing derby, but with the derby back on the table for next spring, we are confident that we can get back on track. We appreciate the support from the Colorado/Wyoming AFS Chapter, and from the biologists that have offered their time to speak at our meetings or be involved with our activities. Our students benefit greatly from this support.

UW Student Subunit, Submitted by Phil Branigan: The UW subunit had an excellent fall semester and will begin the spring semester by helping the Green River office of the Wyoming Game and Fish Department (WGFD) tag burbot in Flaming Gorge reservoir for the upcoming burbot bash. This semester, we will be hosting several speakers including: Mike Robertson (WGFD; Instream Flow-January 29), Christina Barrineau (WGFD; Aquatic Habitat-March 5), and Travis Neebling (WGFD; Hydroacoustic Surveying-April 2). All presentations will begin at 5:30 pm at the UW campus and we encourage visitors to attend. For more information contact Phil Branigan at pbranig1@uwyo.edu.

We will be working with Steve Gale (WGFD) to track brown trout in the Laramie River that were radio-tagged last fall. Several students are gearing up for the annual CO/WY meeting in Fort Collins and are eager to interact with professionals in the field.

The spring semester should be an exciting one for all of the fisheries students here in Laramie!

Looking Back and Moving Forward

October 1 - 4, 2013 Old Faithful Lodge, Yellowstone National Park, USA



The Wild Trout Symposium brings together a broad and diverse audience of governmental agencies, non-profit conservation groups, media representatives, educators, anglers, fishing guides, and business interests associated with trout fisheries to exchange technical information and viewpoints on wild trout management and related public policy. Held every 3 years, each symposium has led to innovative wild trout management approaches.

Wild Trout XI offers a unique forum for professionals and anglers to interact, and where participants are exposed to the latest wild trout science, technology and philosophies. This conference will equip participants to better manage, preserve, and restore these significant but declining resources.

The symposium plenary session will begin by looking back on the history of wild trout research and management, both in terms of past science and the nearly four-decade lifespan of the Wild Trout Symposiums themselves, and wrap up with a look forward to where wild trout management is headed.

The following topics are of particular interest to the organizing committee and may be developed as entire sessions, given sufficient interest. - Struggling with invasive species
- Stressors to, and restoration of, wild trout habitats what have we learned and what do we need to know?
- Brook trout research and management across the species' historic and introduced range
- Role of ecological resilience in wild trout persistence and management, using the past to inform the future

Additional session topics will be added based on the papers that are submitted. Presentations will be accepted in oral or poster format. Please note the authors who are selected for oral presentations at the symposium must submit a complete manuscript ready for Symposium Proceedings publication by June 1, 2013. Successful applicants will receive further information upon acceptance of their paper.
